- 4.2. Jean Bonner stated he had donated a major portion of his display to the Town, but would withdraw his donation if Kevin's project was not approved by the GBA.
- 4.3. Norman Tierney stated that the GBA had \$2,200 in reserve. He stated this project would require a line item within the budget for maintenance, storage, etc.
- 4.4. Two votes on project occurred:
 - (A) Approve/Reject concept of project: Yes 19 No 6
 - (B) Approve/Reject motion of support of project not to exceed \$1,000 Yes - 17 No - 8
- 5.0. Speaker Ken Osborne, Roger Williams University: Town-Gown Relationship
 - Cooperative education occurs on local, national and international level
 - Two out of every three jobs occur within small businesses
 - Finest higher education facilities are in RI 12 colleges and universities
 - What can they provide the small business owner? i.e. in Bristol alone \$2M of income is generated from RWU alone. Re-education and training are available; alleviation of fear of technology for the small business owner; trends in forecasting - which is vital to businesses; partnerships in high tech training; project partnerships for new product developments, etc.; and, availability of interns/cooperative education students in areas of technology, special projects, speakers and expertise, and "make your own 'problem' a class project."
